Status Conference held as requested by plaintiffs as docket no. 177. The conference began at 11:07 a.m. and ended at 12:05 p.m.

- Present were Eliezer Aldarondo, and Sheila J. Torres-Delgado on behalf of the plaintiffs; Claribel Ortiz on behalf of co-defendant Perello-Borras in his official capacity, Javier Burgos Ruiz on behalf of the defendants in their personal capacity, and Wandymar Burgos, Director, Federal Litigation Division of the Department of Justice of the Commonwealth of Puerto Rico, and member of the Settlement Committee of the Department of Justice.

- Parties discussed with the Court as to the contents filed at docket no. 177 in Cv. 13-1560 (PG).
- During today's proceedings, parties submitted a confidential settlement agreement as to the two (2) cases pending before Judge Perez-Gimenez, and the other three (3) additional cases which involve the same defendant, Jaime Perello-Borras, Speaker of the Puerto Rico House of Representatives. *Karla Medina, et. al, v. Jaime Perelló-Borrás, et.al.*, Civil No. 13-1820 (PAD), *Solbee-Malavé, et.al. v. Jaime Perelló-Borrás, et.al.*, Civil No. 13-1895 (PAD); and *Luz Maldonado-Martínez, et.al. v Jaime Perelló-Borrás, et.al.*, Civil No. 15-2738 (GAG). Confidential agreement to be filed in each case.
- In regards plaintiffs' concerns of the validity of the agreement submitted today be questioned by any member of the next administration of the Commonwealth of Puerto Rico, shall be brought to the Court's attention.
- These three (3) cases, *Karla Medina, et. al, v. Jaime Perelló-Borrás, et.al.*, Civil No. 13-1820 (PAD), *Solbee-Malavé, et.al. v. Jaime Perelló-Borrás, et.al.*, Civil No. 13-1895 (PAD); and *Luz Maldonado-Martínez, et.al. v Jaime Perelló-Borrás, et.al.*, Civil No. 15-2738 (GAG) will be transferred to Judge Perez-Gimenez.
- Proposed orders to be served to the Center for Collection of Municipal Revenues, Puerto Rico Department of Treasury, and to ASUME to be provided to the Court for its approval and signature. Orders shall be served by the U.S. Marshals.
