#### Dear Governor Rosselló Nevares:

This letter serves as a Notice of Violation pursuant to Section 202(c)(1) of PROMESA. The Oversight Board has determined, in its sole discretion, that the requested revisions to the certified budget for the Puerto Rico Energy Bureau (the "PREB" formerly known as the Puerto Rico Energy Commission or "PREC") for fiscal year 2019 are not compliant with the New Fiscal Plan for the Commonwealth, as certified on June 29, 2018 (the "Fiscal Plan"). The Oversight Board looks forward to reviewing a revised budget for the PREB that it hopes it can determine is compliant with the Fiscal Plan.

The requested revisions to the certified budget for the PREB are not compliant with the Fiscal Plan because they include an allocation for Christmas bonuses. The Fiscal Plan is clear on this measure. Additionally, the Fiscal Plan establishes that a strong, independent, and expert regulator is required for the successful implementation of the power sector transformation. To this end, Section 9.1.1 of the Fiscal Plan provides that PREB's "Commissioners should be supported in their oversight role by a professional civil servant staff that has utility expertise" yet we observed that over two-thirds of the payroll in the requested revisions to the certified budget for the PREB would be spent on trust employees. Allocating most of the payroll budget for trust employee positions is inconsistent with that aspect of the Fiscal Plan.

Please provide a revised PREB budget that is compliant with the requirements set forth in the Fiscal Plan as well as the necessary corrective actions described herein by August 29, 2018.
